# **Top Matters**

- Acting for a leading privately owned security services company offering security services in connection with a post-acquisition dispute filed before a tribunal appointed by the London Court of International Arbitration in relation to an indemnity claim arising from a dispute pertaining to the terms of a Collective Bargaining Agreement entered into between the company and a union.
