Introduction

This Power Guide has been prepared by ALN Madagascar | Madagascar Law Offices (ALN Madagascar) and provides an overview of Madagascar's power sector. The aim of this guide is to

provide useful information to investors and stakeholders on legal aspects of the industry, such as applicable regulatory standards and tariffs.

Governing Law



 The Constitution of Madagascar, 2010

- Primary Statute:
 - Law No. 2017-020 being the Electricity Code.
- Policy
 - National Renewable Energy Development Plan.

Institutional Framework

The Electricity Regulatory Authority (ARELEC)



ARELEC is the regulatory authority responsible for ensuring the proper functioning and development of the electricity sector in Madagascar. Its functions include regulating tariffs and monitoring the performance of electricity operators.

Ministry of Energy and Hydrocarbons



The Ministry is responsible for the development and implementation of energy policies, including the promotion of renewable energy sources and the regulation of the energy sector. It sets governmental policy and provides strategic coordination of the energy sector. Additionally, it has oversight over JIRAMA.

Office of Mines and Strategic Industries (OMNIS)



OMNIS is the government agency responsible for managing and regulating the strategic mining and hydrocarbon sectors in Madagascar.

Jiro Sy Rano Malagasy (JIRAMA)



JIRAMA is the vertically integrated state owned water and electricity utility company responsible for the generation, transmission, and distribution of electricity in Madagascar.

National Office of Environment (ONE)



ONE is the government agency charged with issuing environmental and social permits, required for all infrastructure projects in Madagascar.

Rural Electrification Agency (ADER)



ADER is responsible for rural electrification through grid extension and/or off-grid and mini grid systems. It aims for electrification primarily by means of renewable energy sources (in order of priority: hydro, solar, biomass, winds, hybrids). ADER's tasks include site identification, tender management and quality oversight of concessionaires.

Economic Development Board of Madagascar (EDBM)



EDBM is an agency of the presidency that promotes investment and strives to improve the business environment in Madagascar. It works with the Ministry, ARELEC and ADER to identify and attract investors to the Malagasy energy sector.



Power Purchase Agreement (PPA) Between the Independent Power Producer (IPP) and the Off taker (JIRAMA)

- The operating term of a PPA is typically 20 25 years.
- Tariff structures are negotiated between the IPP and JIRAMA and may vary depending on the type of power generation technology and project size.
- Payment terms and currency are specified in the PPA and may vary between projects.
- Adjustments to the tariff may be possible in case of changes in law or force majeure events.
- PPA provisions may include liquidated damages for the failure to meet performance and availability thresholds.

- JIRAMA was responsible for approximately 50% of total generation on a concession basis as of February 2019.
- The other half of generation was covered by IPPs and captive plants selling excess to JIRAMA.
- IPPs supply power to JIRAMA under IPP and rental power arrangements.
- There are approximately 80 IPP and rental projects countrywide.

Local Shareholding and Local Content Requirement

• Madagascar's laws and regulations do not impose specific local shareholding requirements for power projects.

Feed-in Tariffs (FIT) Policy

 Madagascar has implemented a FIT policy to promote renewable energy sources, particularly solar, wind, and biomass. The specific tariffs and conditions are determined by the Ministry of Energy and Hydrocarbons based on the National Renewable Energy Development Plan. The FIT policy provides incentives and standard terms for small-scale renewable energy projects.

Payment to Off-taker

 Payment terms and arrangements between the IPP and JIRAMA are negotiated in the PPA. The PPA may specify the payment schedule, currency, and any penalties or liquidated damages for late payments.

Credit Enhancements

 Madagascar's government does not typically provide sovereign guarantees for power projects. However, credit enhancements, such as partial risk guarantees or political risk insurance, may be

Key Approvals/Licenses Required to be Procured.

- Electricity Generation Concession or Authorization issued by the Ministry of Energy and Hydrocarbons.
- Environmental Impact Assessment (EIA) approval issued by the National Environmental Office.
- Connection and grid access approvals from the Electricity Regulatory Authority.
- Relevant permits and authorizations for land use and construction from local authorities.

Governing Law and Dispute Resolution

PPAs and related agreements in Madagascar are generally governed by Malagasy law. Dispute resolution mechanisms, including arbitration, are typically specified in the PPA


