## Introduction

This Power Guide has been prepared by ALN Tanzania | Anjarwalla & Khanna Tanzania (ALN Tanzania) and provides an overview of Zanzibar's power sector. It provides useful information to investors and stakeholders on legal aspects of the industry, such as applicable regulatory standards and tariffs.

Zanzibar is a semi-autonomous region of the United Republic of Tanzania consisting of two main islands, Unguja and Pemba. According to the Constitution of the United Republic of Tanzania and the Union of Tanganyika and Zanzibar Act, 1964 energy is not classified as a "union matter", and therefore Zanzibar has autonomy with regard to decision-making within the energy sector.

## Institutional Framework

Zanzibar Utilities Regulatory Authority (ZURA)



A multi-sectoral regulator responsible for the technical and economic regulation of the water, petroleum, and electricity sectors. Its functions in the sector include licensing, energy regulating tariffs in consultation with the Minister of Water, Energy and Minerals, regulating feed-in tariff on energy, approving reviewing and purchase agreements and controlling the quality and standard of electricity. ZURA is also responsible for promoting effective competition and economic efficiency.

## Ministry of Water, Energy and Minerals (the Ministry)



The Ministry, through the Department for Energy and Minerals, is responsible for policy setting and coordination of the energy issues in Zanzibar. The Ministry also supervises the Zanzibar Electricity Corporation (ZECO) which is the national power utility company.

## Zanzibar Electricity Corporation (ZECO)



ZECO is Zanzibar's national power utility summarily responsible for the generation, transmission and distribution, and sale of electricity on both the Unguja and Pemba islands. It is a vertically integrated public company fully owned by the Revolutionary of Government Zanzibar Government).

Some of the key functions undertaken by ZECO include: (i) the establishment, acquisition maintenance and operation of works and undertakings for the generation, transmission, transformation, distribution and supply of electricity to consumers in Zanzibar; (ii) construction or erecting, alteration and maintenance of machinery, plant, electricity supply lines, mains and other apparatus; (iii) enter into contracts with any public, local authority or any person for the purchase and supply of electricity or for any other purpose; and (iv) to enter into agreements for the purchase of electricity in bulk from independent power producers within or outside Zanzibar for resale to consumers.

## Tanzania Revenue Authority (TRA) and the Zanzibar Revenue Authority (ZRA)



TRA is established by the Tanzania Revenue Authority Act. Its primary mandate is to assess, collect and account for all revenue on behalf of the central government. TRA administers customs, excise, and income taxes in Zanzibar.

The ZRA was established under the Zanzibar Revenue Authority Act No. 11 of 2022. Its main functions include assessing, collecting, and accounting for all revenues under the revenue laws of Zanzibar.

## Zanzibar Public-Private Partnership Department



The Zanzibar Public-Private Partnership (PPP) Department is a coordinating entity for all PPP projects in Zanzibar. It is established under the Zanzibar Planning Commission and serves as the secretariat for the PPP Technical Committee.

Its key role is to ensure that PPP projects conform with the Government's objective by providing technical support to public authorities in the PPP process, ensuring due process is followed and all relevant approvals are obtained.

## **PPP Technical Committee**



This committee is established under the Public Private Partnerships Act, 2015 and is responsible for reviewing project feasibility studies, requests for proposals and contracts for Major Projects (defined below) and providing recommendations to the Principal Secretary of the Ministry of Finance and Planning.

A Major Project is defined in statute as a project which has an investment cost of more than USD. 10 million or a value prescribed by the Minister for Finance under a Legal Notice, results in Government liabilities or is for the provision of monopolistic services.

## Zanzibar Investment Promotion Authority (ZIPA)



ZIPA is a government institution responsible for the promotion and facilitation of investment in Zanzibar. Its functions include: (i) facilitating investment and ensuring a conducive business environment; (ii) acting as a focal point for the promotion and facilitation of investments and business; (iii) providing institutional support for economic development; and (iv) ensuring coherent economic and business policy formulation.

## Zanzibar Environmental Management Authority (ZEMA)



ZEMA is responsible for coordinating, regulating, monitoring, and supervising the environmental management concerns in Zanzibar. Additionally, any approvals and permits required under the Environmental Management Act are obtained from ZEMA as the licensing authority thereunder.

## Public Procurement and Disposal of Public Assets Authority (the PPADA Authority)



The Public Procurement and Assets Disposals Act establishes the PPADA Authority charged with: (i) maximizing efficiency in public procurement; (ii) overseeing the activities of procuring and/or disposing entities; (iii) developing the standard form of contract, bidding, pre-qualification documents and any other public procurement related documents for use by procuring entities; and (iv) registering and maintaining a register of providers of works, services, and supplies among others.

## Power Purchase Agreements (PPA) Between Independent Power Producers (IPP) and the Off-taker (ZECO)

- For the past few years, Zanzibar has been fully dependent on mainland Tanzania for their supply of electricity relying on two PPAs concluded between ZECO and Tanzania Electric Supply Company Limited (TANESCO) for a term of twenty (20) years. In addition, there has been a vacuum on precedent PPAs to rely on in order to adequately provide information on PPAs concluded with IPPs in Zanzibar.
- Nonetheless, Zanzibar has begun diversifying its power sources and reducing its overreliance on TANESCO by recently inking deals with two IPPs for the development of renewable energy power plants. These IPPs include: (i) Astra Energy Inc. which received a letter of commitment in March 2023 from the Government to provide 200 acres of land for the development of a 50MW renewable energy project; and (ii) Taifa Group and Generation Capital Limited which in May 2023 concluded a PPA with ZECO for the development of a 180MW solar power project.

- Regarding tariffs in general:
  - ZURA is responsible for the regulation of tariffs and any tariff contained in PPAs must be approved by ZURA;
  - ZECO may propose any change to retail electricity tariffs/ end-user tariffs, subject to approval by ZURA;
  - the law of Mainland Tanzania applies to foreign exchange controls, and there are no exchange controls in Tanzania that restrict a project company from obtaining payment in freely convertible currency; and
  - the laws in Zanzibar are not clear on the nature of passthrough costs to the consumer.
- Zanzibar laws do not provide for: (a) model PPAs;
   (b) the duration of PPAs concluded between IPPs and the offtaker; and (c) termination rights under PPAs.

## **Local Shareholding Requirements**

- Currently, there are no restrictions on ownership of shares by foreign investors or local equity participation requirements in a project company that intends to set up a renewable energy project. in Zanzibar.
- However, industries in the telecommunications, petroleum and mining sectors are required to adhere to the local shareholding requirements set out under the respective statutes.

## **Government Support Arrangements**

- The Government may provide financial support for PPP projects in the form of government guarantees, tax incentives, capital contributions, land, operating grants, or payments among others.
- Such support is subject to: (i) prior recommendation by the technical committee of the PPP unit; (ii) approval of the Minister in charge of PPPs; and (iii) an assessment on the basis of value for money.

## Key Approvals/Licenses Required to be Procured.

- Provisional license issued by ZURA for conducting assessments, studies, financial arrangements, and other activities necessary for applying for a generation license.
- PPA review and approval by ZURA is required before execution.
- Electricity Generation License issued by ZURA.
- License to practice as a registered contractor with the Zanzibar Contractors Registration Board.
- Environmental Impact Assessment Certificate issued by ZEMA.
- Registration of an entity in Zanzibar with the Business & Property Registration Agency

## **Governing Law and Dispute Resolution**

- There is an overlap between the PPP Act and the PPADA regarding the procurement of power projects in Zanzibar. The PPP Act provides that the parties to a PPP Agreement are free to choose the law governing their relations while the PPADA is silent on the issue.
- The dispute resolution and arbitration framework in Zanzibar is nascent. The Arbitration Decree, which sets out the rules and procedures to be followed with respect to arbitration proceedings
- in Zanzibar, only applies to arbitration to which the Government is a party.
- Mainland Tanzania ratifies international treaties or conventions on behalf of Zanzibar, on this basis Tanzania has ratified the New York Convention, but it has not enacted the same in its municipal laws. The convention cannot therefore be relied upon for the domestic enforcement of a foreign award.




